Dear Katharina,

I am really glad that VP Schinas reached out to you and it will be wonderful to have you!! Also, especially since he "delegated" you, you can make the point of speaking on his behalf a bit, I'm sure. In fact I think it would be a best practice for me to include you in any future invitations/communications with commissioners/vps OUT OUT OF SCOPE Regarding moves in the Commission, there's certainly plenty to speak about indeed - I understood that the communication was actually coming on the day of the event, the 10th of June - but if it's this week, even better, we'll have some time to digest it.

Format

Regarding the format there are two options and you can tell me what you prefer - I am very, very happy with both.

 One is that you would speak in the beginning, together with (tbc) and who are just giving welcome remarks and maybe reflecting at the end. They will probably say broad things mostly focused on conspiracies, and more on the emotional side (I suspect). So you would be the one saying the more substantial specific things. The framing here would be that the 3 of view speak from the policy making side and the 3 panelists from the civil society side

2. The second is that you'd have a more interactive role, as part of the panel - bringing the perspective of the Commission to the actual discussion - we would start with you so you could give an overview and then each panelist would have an opening question that allows them to elaborate on their own field of expertise. Then we would have a few back and forths. The framing here would be more that the 2 MEPs are the hosts, just giving the welcome remarks and then there is the actual panel.

Audience:

It will indeed be a bit different than the other talk, and really also the content is different. First of all, my colleague and I will be moderating. The audience is both the BBI contact list and our Brussels office "baby" database. We would be really glad of course if you circulated it as well - we'll have a poster by Friday.

Separate from all this, a thought on the DSA: I went through it and even just understanding the structure took me a million years. Some parts seem very relevant, others less. I wonder if there is any concerted effort that we could do as the Jewish orgs? I was thinking to invite "everyone" for a call, to flush this out. Maybe once we make submissions we could put out a joint letter saying "we submitted and these were our main requests" - to have something more public and underlining that we all agree on certain crucial points. If you have any thoughts on this, let me know:) Many thanks again Katharina, really looking forward, and sorry about this enormous email!!
